# Reform of disability employment will be impacted by....

# Disability Employment Services (DES) reform

- In October 2022 the Government announced a phased approach to reforming disability employment.
- The first step of this process is to extend the current DES program to 30 June 2025, with some immediate changes to current DES program, including a quality framework to improve service quality for participants.
- The new model will:
  - continue the greater focus on quality;
  - provide employment services to people with disability who are subject to mutual obligation requirements and those who are not;
  - have greater integration with other programs and services, such as Workforce Australia and the NDIS; and
  - provide flexible support which meets the needs of people with disability.

### **Quality Framework**


The aim of the new quality framework is to work with the sector and other stakeholders towards mutual quality aims

- The new DES quality framework supports the existing Key Performance Indicators.
- Public consultation from 19 December 2022 to 13 March 2023.
- Further targeted consultation to occur throughout June.
- To commence from July 2023.



#### Centre of Excellence

- Centre of Excellence
  - Inform and guide best practice across the sector.
  - Improve employment outcomes for people with disability.
- Consultation to be undertaken this year.
- Implementation to commence mid 2024.
- How do we build on what is already out there?



#### NDIS/DES Pathways Pilot

### Aim: To improve pathways into the DES program for people without mutual obligation requirements

- 53,300 NDIS participants in receipt of the Disability Support Pension (DSP) have indicated they *want* to work
- The department is working with the NDIA and Services Australia to develop the pilot
- Consultation with NDIS participants, Disability Representative Organisations (DROs), and DES provider peak bodies to help define the scope of the pilot.

#### Visitor Economy Disability Employment Pilot

The Pilot will test a new approach to supporting tourism employers with local Navigators to connect with employment service providers and/or jobseekers with disability

- The Pilot will address barriers in recruiting, retaining and progressing jobseekers.
- 12 successful grant recipients announced on 3 June 2023.
- Navigators will be funded from July 2023 to June 2024 in targeted locations.

#### Business Council of Australia – Disability Employment Initiative Pilot

The Pilot will encourage large employers to create long-term jobs and career advancement opportunities for people with disability

- Funding from July 2023 to July 2024.
- The Pilot will aim to narrow the gap between the employment levels of people with disability and those without disability by:
  - driving attitudinal change;
  - encouraging Australia's largest employers to focus beyond entry level jobs; and
  - driving long-term employment outcomes career advancement, leadership.

#### Supported employment

- \$52.7 million was announced in the 2023-24 Budget to assist the supported employment sector to evolve.
- Provide people with disability with high support needs, their families and carers with access to greater advocacy and information.
- Six initiatives:
  - Structural Adjustment Fund
  - 2. Transition to the revised Supported Employment Services Award
  - 3. Consultation on a disability business procurement initiative
  - Conducting an evaluation of supported employment initiatives and trials
  - 5. Job expos
  - 6. Targeted advocacy and information supports
